#### **TOPIC:** Finance Committee

DISCUSSION:

 Cheryl Lomax, Finance Committee Chair, presented highlights of the FY18 financial statements through June 30, 2018.

## **TOPIC:** Budget Update

**DISCUSSION:** 

Greg Giornelli, CEO, reviewed the Sources & Uses of Cash Forecast for next 7
years showing a breakeven in 2025. Greg also provided an update that the
New Market Tax Credit loan was paid off and discussed other related
matters.

## **TOPIC:** Organizational Priorities

**DISCUSSION:** 

 Ryan Shepard, President discussed the 3 priority areas for the current school year: Student Culture, Organizational Culture and Culture of Achievement. Our 2018 – 2019 priorities will be reinforced through our ReFresh Fridays initiative. For FY19 there is early dismissal for students every Friday to allow for professional development with an emphasis on small group instruction.

#### **TOPIC:** Academic Results

**DISCUSSION:** 

 Barbara Preuss, Head of Schools discussed PBSA School Demographics and % of directly certified students. Barbara also reviewed comparison of overall school achievement in all subjects prior to PBSA against current state.

## **Standing Updates:**

# **TOPIC:** Instruction – Enrollment Update

**DISCUSSION:** 

- Barbara Preuss reviewed enrollment numbers since start of school on July 25, 2018. Enrollment is significantly down across all schools. The renovation work being completed at Forest Cove Apartments located across the street from Thomasville Elementary may be directly impacting their decline in enrollment. Slater Elementary experienced significant growth in FY18 however enrollment is down so far in FY19. In addition, it appears that all of the Price students did not transition to Carver STEAM Academy.
- Greg Giornelli commented that any decrease in student enrollment directly impacts per pupil funding received monthly from Atlanta Public Schools.
   Greg stated PBSA Senior Leadership will immediately review the budget to identify areas to offset any potential loss to address possible budget gap.

 Ryan Shepard, President, announced Christina's Perry departure as Chief Community Officer has created a vacancy. Ryan is providing leadership for the Community Engagement team in the interim and there are no immediate plans to fill the Chief Community Officer position.
